Note:

1. The Selection is purely provisional. If any documents submitted by the Candidates are found to be incorrect/invalid in future, those candidates' selection will be invalidated for this recruitment.

As per direction of Hon'ble Supreme Court of India the candidate who are pursuing Diploma in Cooperation / prescribed training should enter an agreement with the institution to which they are allocated. After successful completion of the prescribed training within a period of one year and upon submission of proper certification for the same, the appointment order will be issued to them by the respective Cooperative Institution. Failure in completion of the prescribed training within a period of one year result in automatic cancelation of the particular candidate's selection.

The selection of candidates is purely provisional subject to the outcome of writ petitions relating to this recruitment which is filed in the Hon'ble High Court of Judicature at Madras and other writ petition if any filed before the Hon'ble High Court of Judicature at Madras / Madurai Bench of the Madras High Court.
