After successful completion of the prescribed training within a period of one year and upon submission of proper certification for the same, the appointment order will be issued to them by the respective Cooperative Institution. Failure in completion of the prescribed training within a period of one year result in automatic cancelation of the particular candidate's selection.

The selection of candidates is purely provisional subject to the outcome of writ petitions relating to this recruitment WP 33696 /2023 which is filed in the Hon'ble High Court of Judicature at Madras and other writ petition if any filed before the Hon'ble High Court of Judicature at Madras / Madurai Bench of the Madras High Court.
